Report for APS P&C AGM 2019: Band

2018 was another busy and successful year for Artarmon bands. Approximately 250 students from years 3 to 6 participated in the band program in 2018.

In 2018 we had a Training Band, three Concert Bands (Junior Concert Band, Concert Band, Senior Concert Band) plus Jazz Band. In addition, band students joined with strings students in Orchestra. As Training Band had a large number of students, they rehearsed in two groups, with Mr Cameron Harker sharing the conducting with Matthew Walmsley, with the conductors alternating so that the two groups had the benefit of both conductors' styles and expertise.

Bands performed at various school events throughout the year including the Easter Band Breakfast, Open Day, the P&C's Spring Fair, the Concourse Concert, OC orientation, Carols Night and Presentation Days.

All the Concert bands and Orchestra participated in and achieved successes in various festivals and competitions including Sydney Eisteddfod, Ryde Eisteddfod and NSW School Band Festival. Senior Concert Band, Jazz band and Orchestra were all placed first in their group at the Sydney Eisteddfod. Senior Concert Band also had the opportunity to perform at the Northern Youth Symphonic Winds 10 Year Anniversary Concert.

An overnight Music Camp, a joint event for Band and Strings Students in Years 4 - 6, was held at Galston in August, in preparation for the Concourse Concert.

The music room office was divided into 3 tuition rooms at the end of the year. The works are funded jointly by the band and strings committees with assistance from the P&C, for which we are very grateful.

We are looking forward to performing in the new school hall in 2019. In anticipation of this we have ordered a new set of timpani so that one set can be kept for performances in the hall, reducing the risk of likely damage with moving the equipment 'long distance' between the music room and the hall.

Financially, band ended the year in a positive position, although major expenditure (the music room works) was budgeted but will not be paid for until 2019. We have calculated the future staff long service leave commitment and have put aside sufficient funds in a term deposit account to cover this. The annual financial statement is attached.

I would like to thank the school executive for their support and assistance in 2018, in particular Mrs Green and Mr Coombes (and Mrs Justine Miller in the first part of the year), and Mr Matthew Walmsley for his direction of the band.

I would like to thank all the parent volunteers, especially those in the band committee, without whom the band program would not be possible.

I hope all the students enjoyed being part of band in 2018 and will continue making music in 2019.
